## AN EMERGENCY RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR AND PRESIDENT OF COUNCIL TO ENTER INTO CONTRACT WITH STRYKER PROCARE SERVICES FOR A TWO-YEAR TERM TO PROVIDE MAINTENANCE TO THE AMBULANCE POWER LOAD SYSTEM AND POWER COTS IN THE AMOUNT OF \$13,278.70

WHEREAS, based upon the recommendation of the Fire Chief, it has been deemed in the best interest of the health, safety and welfare of all Village residents and inhabitants to enter into a service agreement for the maintenance of the Village's ambulance power load system and power cots; and

WHEREAS, Stryker ProCare Services ("Stryker") provides these maintenance services; and

WHEREAS, the Mayfield Village Fire Chief reviewed the proposal of Stryker and recommends that the Village enter into contract with Stryker for a two-year term in the amount of \$13,278.70 for maintenance of the Village's ambulance power load system and power cots.

## BE IT RESOLVED BY THE COUNCIL OF MAYFIELD VILLAGE, OHIO, THAT:

- SECTION 1. The Council of Mayfield Village does hereby direct the Mayor and President of Council to enter into contract with Stryker for a two-year term for maintenance of the Village's ambulance power load system and power cots in a form substantially similar to the Agreement attached hereto and incorporated herein as Exhibit "A".
- SECTION 2. The Council of Mayfield Village further authorizes an expenditure in the amount of \$13,278.20 for maintenance of the Village's ambulance power load system and power cots.
- SECTION 3. The Council finds and determines that all formal actions of this Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and that deliberations of this Council, and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including requirements of Section 121.22 of the Ohio Revised Code.
- <u>SECTION 4</u>. This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of health, safety and welfare of the residents of Mayfield Village, Ohio, for the reason that it provides for necessary services and equipment to ensure that the Village Fire Department is properly supported. It shall, therefore, take effect

immediately upon the passage by the affirmative vote of not less than five (5) members elected to Council and approved by the Mayor or otherwise at the earliest time allowed by law.
