## AN EMERGENCY RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR AND PRESIDENT OF COUNCIL TO ENTER INTO AN AMENDMENT TO APPENDIX A TO THE BILLING SERVICES AGREEMENT WITH LIFE FORCE MANAGEMENT, INC.

WHEREAS, pursuant to Ordinance No. 2009-08, the Village authorized and directed the Mayor and President of Council to enter into a Billing Services Agreement with Life Force Management, Inc.; and

WHEREAS, pursuant to Ordinance No. 2011-06 and 2014-02, and Resolution No. 2020-48, the Village authorized and directed the Mayor and President of Council to amend the billing instructions set forth in the Billing Services Agreement with Life Force Management, Inc.; and

WHEREAS, in coordination with Life Force Management, Inc., it has been deemed necessary once again to amend the billing instructions and the usual, customary and reasonable costs ("UCR") set forth in Appendix A of the Billing Services Agreement with Life Force Management, Inc.

### BE IT RESOLVED BY THE COUNCIL OF MAYFIELD VILLAGE, OHIO, THAT:

<u>SECTION 1</u>. The Mayor and President of Council are hereby and herein authorized and directed to enter into an Amendment to Appendix A to the Billing Services Agreement with Life Force Management, Inc. in a form substantially similar to that attached hereto and incorporated herein by reference as Exhibit "A".

SECTION 2. The Council finds and determines that all formal actions of this Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and that deliberations of this Council, and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including requirements of Section 121.22 of the Ohio Revised Code.

<u>SECTION 3</u>. This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of health, safety and welfare of the residents of Mayfield Village, Ohio, for the reason that it provides for the administration of billing for emergency services. It shall, therefore, take effect immediately upon the passage by the affirmative

vote of not less than five (5) members elected to Council and approved by the Mayor or otherwise at the earliest time allowed by law.
