The Council of Mayfield Village met in Regular Session on Monday, September 19, 2022, at Mayfield Village Civic Hall at the Mayfield Village Civic Center. Council President Schutt called the meeting to order at 7:03 p.m.

Council President Schutt asked, Mrs. Betsa, may I have a Roll Call, please?

Council President Schutt stated, thank you, Mrs. Betsa. Please let the record show that Councilman Murphy and Mr. Cappello are both excused from this evening's meeting.

The Pledge of Allegiance to the Flag was given.

. Presentation of Commendation to Officer Stipe Bajan

Council President asked, Mayor Bodnar?

Mayor Bodnar stated, thank you, Council President. Tonight I have the honor of recognizing Patrol Officer Stipe Bajan for his exemplary service in the line of duty. Officer Bajan I have issued a Commendation to you and if you will stand I will read it into the record:

Dear Officer Bajan:

On August 30, 2022, a small airplane crash landed behind Mayfield Middle School in Mayfield Heights. Not knowing the severity of the crash, Officers Andy Duffy and Stipe Bajan both responded to assist Mayfield Heights Police. As one of the first on-scene officers, Officer Bajan observed that one of the passengers of the airplane had a severe laceration on his arm. Without delay, Officer Bajan began delivering medical care to the man by applying a tourniquet to his injured arm and assisting with treatment until the man could be transported to the hospital. It turned out the man was the pilot. I have no doubt that your skill and quick action saved the pilot's

arm and quite possibly his life. Your immediate observation of the situation, recognition of its severity, and quick response shows your dedication and professionalism. Your response to this incident exemplifies the finest Mayfield Village has to offer and I am pleased to present this Commendation to you for your actions on August 30, 2022.

Council President Schutt stated, next, I would like to welcome Brian Thunberg, Government Liaison for the Northeast Ohio Regional Income Tax Agency. Mr. Thunberg?

. Proclamation presented by Brian R. Thunberg, Government Liaison Northeast Ohio Regional Income Tax Agency recognizing Mayfield Village for being an original member of RITA and our 50-year partnership.

Good evening Council President Schutt, Mayor Bodnar and all distinguished members of Council. My name is Brian Thunberg. I am the Government Liaison of the Regional Income Tax Agency. The reason why I am here this evening is to present Mayfield Village with a Proclamation of our partnership over the last 50 years. Also, with regard to income tax, I am opening up for questions to Council afterwards.

The Regional Income Tax Agency and Mayfield Village have partnered together for nearly a half century. RITA, founded in 1971, by 38 member municipalities established a central collection facility to administer income tax to all of those local communities. RITA has celebrated 50 years of serving Ohio communities and their taxpayers while growing to more than 360 members in 70 counties in the State of Ohio. RITA now collects for approximately 50% of the State of Ohio, nearly \$2 billion in local income tax. The Regional Income Tax Agency's Board of Trustees as the governing body of the Regional Income Tax Agency wishes to recognize and thank Mayfield Village for its participation in and the founding of and the continued success of the Regional Income Tax Agency. At this time, I would like to present this Proclamation to Mayor Brenda Bodnar and the entire Administration of Mayfield Village. Thank you very much Mayor for your partnership over the last 50 years. We look forward to another 50 years.

Mayor Bodnar stated, we are also. Thank you. I would like to say that on behalf of Mayfield Village, we are very proud partners in RITA and we are very appreciative of all of your leadership, dedication, professionalism and especially your guidance over the last couple of years. . State of the Schools Presentation – Dr. Michael J. Barnes, Superintendent of Mayfield City School District.

Dr. Barnes stated, thank you Council President Schutt, Mayor Bodnar, Council members and staff. We are excited to be here to share some brief comments tonight on the State of the Schools. We will share some highlights from last year. We will talk about our strategic priorities in 2022, 2023 and beyond. Mr. Snyder then will have some commentary on some capital improvements, operations. We will then open it up for questions if you have any at the end. We promise to be efficient. We know that Council has a lot of work ahead of them. We are very very thankful for this opportunity to come and spend some time with you all.

Tying it all together, Dr. Barnes stated, we have a vision for learning. It's entitled personalization meaning we want to help each and every single student where they are and make adjustments either to enrich or to provide interventions if necessary. We also want them to have skills like collaboration, thinking, communication. We are working with the Board to continue to manipulate the spaces so they compliment our vision for learning. We are excited about that. We will have an open house at the Middle School in October. On November 4th, we will have a number of Superintendents visiting Mayfield Schools to look at some of our innovative programming. We are presenting in Houston, TX next week. We were invited. Are there any questions?

Mr. Williams asked about personalization. How do you meet a student where they are?

Dr. Barnes stated, the first question we want to ask is what do we want students to be able to do. That's our fundamental question in our professional learning communities. We have to detect the sanctity of that. The second question is how do we know that they got it? That's our assessments.

We assess the students based on the State's standards. You will know whether or not he/she has met the standard, are below the standard or exceed the standard. It's at that time the teacher then personalizes the experience for each student to make sure he/or she grows. Personalization is taking all students and moving them, breaking it down by their name, by their ability.

Mr. Williams stated, thank you. Also, I brought this up with Dr. Kelly, vocational education – how do you address that?

Dr. Barnes stated, Mr. Snyder and I are both on the board of two consortiums, ExcelTech. We offer programming from CAD to construction trades to culinary arts. It's a very popular program. Our students apply. It's a very valuable experience for students. We also have the workforce development career program in CEVEC for students with disabilities so they can become independent as a graduate from Mayfield High School.

Mr. Williams stated, that's great to hear. Thank you.

A member of the audience asked with regard to personalization – both of her children who are at Center went through the 3rd grade classroom where they combined it into one and they are doing the co-teaching module. For my kids, that's been really successful, but there's a space limitation. I am curious what the developments for that program might be. Was it just a pilot? Are you looking to expand that?

Dr. Barnes replied, that's personalization at is finest. That was a great description. Whenever there's space limitations – Center is growing as well. We are going to try to address some of those things.

Another member of the audience asked about whether or not they would be bringing back the open school concept at Center School. It was so successful with my kids. They got a college education before they even went to high school.

Mr. Snyder stated, personalized learning might address some of that. We have a blend of that. Open school concept was back in the 1970's. Some of the pluses of that are still being applied today. We are doing it with personalized learning.

Another question from an audience member – do you have problems hiring teachers?

Dr. Barnes stated, fortunately not. If we post a job we get 150 applicants. We are struggling with substitutes and staff challenges in our operations.

Mrs. Jurcisek stated, you mentioned CEVEC is moving up to the Innovation Center with the expansion. What will you be doing with the CEVEC building at the Middle School right now?

Mr. Snyder replied, we are going to repurpose it. Right now, we are looking at traffic pattern improvement by moving it out. It backs up right now. We need the traffic to flow better. Mayor Bodnar stated, I don't have any questions, but I have a few comments if that's okay. Dr. Barnes, Mr. Snyder and members of the School Board, your successes are always impressive. You continue to benefit all of our students and all of our communities year after year. Thank you for your vision, your leadership, your strategic planning, your fiscal responsibility. It is truly an honor to be a member community in the Mayfield School District. Thank you.

Dr. Barnes stated, if there are no other questions, we will yield. Thank you so much for your time. We really appreciate this opportunity to spend some time with you. Thank you.

Council President Schutt stated, I would just like to echo what Mayor Bodnar said as well. Thank you Dr. Barnes, Treasurer Scott Snyder and the School Board members who are here, Mr. Hess and Mr. Fornaro. Most of us sitting here live in Mayfield Village and we obviously live here because of the community it is but also because of the School District that we have here. Thank you for all of your hard work. We appreciate it.

Diane Calta came to the meeting and talked about our ADA transition plan that the Village is currently working on. We also talked about the upcoming ballot issues on the November ballot and reviewed some informational material that is going to go out to residents. Daniel Russell (Building) – Thank you, Council President. I will be reporting on the past Planning and Zoning workshop and ARB meetings we have had the past few weeks. On August 25th ARB met and we had three proposals. The first was an addition to Center Elementary School. The second was an addition to the Innovation Center and the third was an addition to Yours Truly Restaurant. Center School was approved at that meeting. The Innovation Center was denied because they needed a little more information. Yours Truly was tabled for additional information. On September 8th, they had two proposals, the Innovation Center came back and the changes were approved. An in-ground pool was approved on SOM Center. Lastly, Planning and Zoning had a workshop on September 15th. Two proposals were on the docket, site plan approval at Center School and the Innovation Center.

Council President Schutt stated, thank you, Mr. Russell.

Diane Calta (Law) – Thank you, Council President. There are two items on the agenda that we have not discussed that I wanted to mention. They are 2022-38 and 2022-39. They relate to participation in two separate settlements for the opioid litigation that the State of Ohio has been litigating. This was brought to my attention by the Mayor back in August. We have been discussing the ability of the Village to participate in those settlements. They are still open to having municipalities participate and now that they have the funds that they are starting to distribute, we took a closer look at it and looked to see if whether or not any of those funds would be available to the Village for expenditures that we would be looking at. They have a Memorandum of Understanding that outlines what all of the funds can be used for. We talked with the Police Chief, Ron and the Mayor and we discussed this at the Department Head meeting. There are some uses for the funds for basically training, largely what looks to be in the Police Department but could be other trainings for the Village or the community. They have an estimated worksheet of how much the Village could be receiving. It's just an estimate. It's over 18 payments. I can't represent exactly how much the Village could be receiving. They did distribute the first tranche of payments. But it looks to be in total, Ron, for both of these settlements if they pay out over those 18 months- a lot of it is going to be dependent on how many people participate in the settlement, but around maybe \$30,000-40,000 based on the worksheets. I can't guarantee those, but in looking at the ability to participate, the ability to use the funds, we thought it would be appropriate to ask Council for authorization for the Mayor and the Council President to participate in those two settlements. So those are the two pieces of legislation we added. Are there any questions?

There were none.
