Comments from Mayor Bodnar

Thank you, Council President. Just a couple of things this evening. First of all, I would like to thank everybody who participated in and was involved in with the set-up of our Shred Day on Saturday. I was able to take advantage of it for my full five boxes. It is wonderful when we have those. Thank all of you who came on Saturday and worked at it and thank all of you who planned it also.

The second thing I wanted to talk about briefly was just to give a little bit of an update on the municipal tax issues. I am sure you have all been reading about it in the paper or hearing about it from one source or another. The status of that is this, we have two pending and conflicting pieces of proposed legislation out there. There's House Bill 157. It is not a part of the budget, but what that Bill does is it allows individuals who are currently working from home but who have been

paying taxes at the City where their office was located to file for income tax refunds back through January 1, 2021. We also have the budget bill which is House Bill 110 and in that Bill the Senate would allow retroactivity back through 2020. Now as you know, we were originally promised through the State Legislature in their actions that there would not be any retroactivity. We are still pushing for that. At this point, all the conflicts in the different versions of the budget go to Conference Committee. The House has selected its three members for their end of the Conference Committee. We have been keeping an eye on things. We don't see that the Senate has selected its three members to go to Conference Committee. They need to do so quickly. Once they get the Conference Committee, they will have to work out the differences and get it back to both Houses for a full vote. They need to vote on the budget by the end of June. So that's coming up and it's coming up quickly. There are many municipalities including us and there are many legislators who want to avoid retroactivity of any sort. We have been in touch with all of our legislators. We have been in touch with all of the people that are pushing the different versions of the Bill to let them know where we stand. We have been working with Mayor's groups. We were working with the Governor's office. We had a call with Michelle Gillcrist this afternoon that was very productive, so we have a lot of people on our side. There's still a great push for no retroactivity. We won't know that exactly until the end of this month, but we are doing everything in our power. On a continuous basis, Ron, Diane and the departments have been closely reviewing our budget so that we are prepared for the future.

So that's my report. Thank you.

Mr. Wynne stated, just as a reminder for Council, this is an annual requirement we have with the Cuyahoga County Budget Commission. The purpose of this Alternative Tax Budget is really two-fold. One is to let the County know that the property tax money that we receive every year as to how we want it allocated amongst our funds. We have had no change in how we are going to do our allocation. The majority of it goes to the General Fund with a portion of it going to the Police Pension, Police Operating Fund. The second purpose of this is to itemize our outstanding debt so

that the County can see that we have sufficient resources coming in from other than property taxes to make the principal interest payments on that debt without having to allocate property tax dollars for that purpose. This is required to be passed by July 15th and submitted by July 20th to the County.

Mr. Wynne reported, yes, our annual renewal after going out to market, came in at \$125,907. This is 4.8% higher than our premiums last year of \$120,184. We request \$130,000 because after the renewal over the next 12 months we typically add vehicles and sell vehicles at the same time so the additional \$3,000-4,000 is the company insurance premiums on those new vehicles that we will purchase and then we get an insurance reimbursement which goes into revenue as a miscellaneous reimbursement.
