AN EMERGENCY RESOLUTION AUTHORIZING THE MAYOR AND PRESIDENT TO COUNCIL TO ENTER INTO A POLICE FIRING RANGE USE AGREEMENT WITH THE UNIVERSITY CIRCLE POLICE DEPARTMENT

WHEREAS, the University Circle Police Department desires to utilize the Mayfield Village firing range for firearms training activities; and

WHEREAS, Mayfield Village has agreed to allow the University Circle Police Department to utilize the Mayfield Village Firing Range subject to certain terms and conditions; and

WHEREAS, Council deems it necessary and in the best interest of the health, safety and welfare of all Village residents to enter into the Police Department Firing Range Agreement with the University Circle Police Department in order to set forth certain terms and conditions for the use of the Mayfield Village Firing Range.

BE IT RESOLVED BY THE COUNCIL OF MAYFIELD VILLAGE, OHIO, THAT:

<u>SECTION 1</u>. The Council of the Village of Mayfield authorizes and directs the Mayor and President of Council to enter into the Police Department Firing Range Agreement with the University Circle Police Department, a copy of which is attached hereto and incorporated herein as Exhibit "A".

SECTION 2. The Council finds and determines that all formal actions of this Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including requirements of Section 121.22 of the Ohio Revised Code.

<u>SECTION 3</u>. This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of health, safety and welfare of the residents of Mayfield Village, Ohio, for the reason that it provides for necessary terms and conditions for use of the Mayfield Village firing range. It shall, therefore, take effect immediately upon the passage

by the affirmative vote of not less than five (5) members elected to Council and approved by the Mayor or otherwise at the earliest time allowed by law.

EXHIBIT A

MAYFIELD VILLAGE POLICE DEPARTMENT FIRING RANGE USE AGREEMENT

(Law Enforcement Agencies)

This Use Agreement, is made this 1st day of xxxx 2023, (the "Effective Date") by and between MAYFIELD VILLAGE, an Ohio municipal corporation through its Police Department ("Mayfield Village") and THE UNIVERSITY CIRCLE POLICE DEPARTMENT ("Participating Agency"), provides for Participating Agency to use Mayfield Village's Firing Range ("Range") at 620 SOM Center Road, Mayfield Village, Ohio 44143 for authorized firearms training activities subject to the terms and conditions outlined below.

- Participating Agency refers to any public law enforcement agency that wishes to conduct firearms training activities at the Range. Use of the Range is authorized for and limited to licensed officers of the Participating Agency. No unauthorized persons will be allowed to use the Range.
- 2. The term of this Use Agreement shall be three (3) years, commencing on the Effective Date (the "Term"). Mayfield Village shall have the right, in its sole discretion, to terminate this Use Agreement at any time during the Term upon written notice to the Participating Agency.
- Participating Agency agrees to pay Mayfield Village a fee of five hundred dollars (\$500.00) annually prior to the commencement of each year in the Term. Payment balances will be refunded to the Participating Agency for whole years on a prorated basis in the event of early termination in accordance with this Use Agreement.
- 4. The time, date, and duration of the Participating Agency's use of the Range will be scheduled and approved by the Range Officer.
- Participating Agency shall at all times adhere to the rules and regulations of the Range and Mayfield Village Range Policy, both attached hereto, and incorporated herein, as Exhibit A, as applicable, and shall be subject to the guidance and authority of the Range Officer, or his/her designee.
- Participating Agency agrees to provide a Certificate of Insurance evidencing coverage for general liability insurance, auto liability insurance, and workers' compensation insurance, covering all Participating Agency's personnel, prior to its use of the Range. Such Certificate of Insurance shall name Mayfield Village and the Mayfield Village Police Department as additional insureds.

EXHIBIT A

FIREARMS SAFETY

Safety in the use and possession of firearms is a subject which must be constantly readdressed. The purpose of this course is to act as a refresher for all of us.

- 1. Firearms safety while on duty and while carrying a weapon off-duty.
 - A. Always keep your weapon clean and properly lubricated. (Refer to owner's manual or seek advice from a range officer or dept. armorer.)
 - B. Always have fresh duty ammunition in both your weapon and extra magazines.
 - 1. NEVER carry ammunition, which is corroded, dented or in any way damaged.
 - 2. **NEVER** use ammunition, which is old or non-issued in your duty weapon.
 - 3. Make sure you have the correct ammunition for your firearm. Just because it fit, does not mean it will function in the weapon. (i.e., .22 cal / .25 cal; .380auto / 9mm; 12ga. / 16ga.; ECT.)
 - C. It is highly recommended that RELOADS not be used in semi-auto weapons.
 - 1. Casing fatigue.
 - a. Every time a cartridge is fired, the casing expands and needs to be resized. This causes thinning of the case walls.
 - b. 9mm ammunitions are usually loaded to high pressures and casing fatigue may cause a dangerous condition.
 - 2. Improper powder charges.
 - a. Too weak of a charge may cause the bullet to become lodged in the barrel, or may not cycle the slide fully.
 - b. Too powerful of a charge may damage a weapon and cause serious injury.
 - 3. High primers.
 - a. Primers may not be seated fully and could cause feed jams.
 - 4. Poor crimping.
 - a. Bullet could be off center, seated too deep or not deep enough.
 - 5. Foreign matter.

a. Foreign matter could be between the primer and powder charge. This could result in a miss-fire or a hang-fire.

D. Field stripping.

- 1. You should field strip your weapon at least weekly or more if you work road jobs where you are subjected to weather and dirty conditions.
 - a. You should check your weapon for FUNCTION, CLEANLINESS, and EXCESSIVE wear.
 - b. Any problems or questions should be directed to any range officer or dept. armorer.
- E. **NEVER** allow anyone other than authorized personnel to handle your weapon.
- 1. <u>DO NOT</u> hand your weapon to another officer while handcuffing or searching a suspect. <u>HOLSTER YOUR WEAPON!!!</u>
 - 2. Do not let a civilian handle your weapon.
 - 3. <u>NEVER</u> un-holster your weapon for un-necessary reasons.
- F. **DO NOT** leave your weapon lying around the station.
 - 1. Keep it holstered at all times.
 - 2. Lock your weapon in a weapon locker and take the key with you.
- 3. When using the restroom, keep your weapon under your control at all times. **DO NOT** leave it or your gun belt lying on a table or in the locker room.
- 4. **DO NOT** leave your locker **UNLOCKED** if you have any weapons (off-duty etc.) in the locker.
 - 5. <u>ALWAYS</u> secure your duty weapon prior to leaving at the end of your shift.
- G. DO NOT engage in "Quick Draw" exercises, gun twirling or other childish games.
 - 1. Officers and others are killed or injured constantly by these types of games.
- H. Be conscious of your weapon while in public, especially in crowds or at Restaurant counter.
 - I. "Holster Carry" for semi-auto pistols,
 - 1. Round in the chamber.
 - 2. Weapon de-cocked if weapon is first round double action. (Beretta, Smith & Wesson, Sig Sauer, ECT.)
 - 3. De-cocking lever in the fire position if so equipped.
 - 4. Magazine fully loaded.

II. Shotgun Safety.

A. "Cruiser Carry" (A.K.A. Condition #3)

- 1. Chamber empty.
- 2. Weapon un-cocked.
- 3. Safety off.
- 4. Magazine fully loaded.

B. "Shotgun Carry"

- 1. Port arms position.
 - a. Strong hand on pistol grip. Finger outside of the trigger guard,
 - b. Weak hand on slide.
 - c. Weapon at a 45-degree angle across body muzzle up.
 - d. Weapon should only be "Charged" is shooting is Imminent.

C. Returning Shotgun to cruiser.

- 1. Make weapon "Safe" by returning it to "Cruiser Carry" or Condition #3 before returning weapon to the lock.
- 2. You should always check the shotgun in your cruiser at the start of your shift to ensure that is in "Cruiser Carry (Condition #3) and that the magazine is fully loaded.
- D. Conditions of a Shotgun.
 - 1. Condition #4.
 - a. Weapon completely empty. Chamber and Magazine. Safety in on position. Action open.
 - 2. Condition #3.
 - a. Chamber empty.
 - b. Weapon un-cocked.
 - c. Safety off.
 - d. Magazine loaded.
 - e. Action closed.
 - 3. Condition #2
 - a. Round in the chamber
 - b. Safety ON.
 - 4. Condition #1.

- a. Round in the chamber.
- b. Safety OFF.
- III. Firearms safety at the range.
- A. The range is a high-risk area. Most accidents at the range occur because of the following:
 - -1. Horseplay or Goofing around.
 - a. Such actions may result in removal from the range and possible disciplinary actions.
 - 2. Failure to listen to the range officer's instructions.
 - 3. Improper positioning of the shooter in the stall.
 - 4. Failure to ask for help when needed.
 - 5. Pointing weapons in any other direction other than down range.
 - 6. General nervousness.
 - a. "I have to qualify".
 - b. Embarrassment of not being a good shot.
 - B. Loading and Unloading of firearms.
 - 1. All <u>LOADING</u> and <u>UNLOADING</u> of firearms is to be done on the range while in the stall with muzzle pointing down range.
 - a. An exception would be to use the "Bullet Trap" located on the wall in the weapon cleaning area if immediate loading of a firearm in an emergency.
 - 1. Insert loaded magazine into the firearm.
 - 2. Chamber a round while the muzzle is pointed downward into the center of the "Bullet Trap" <u>**DO NOT**</u> HAVE THE FIREARM TOUCHING THE TRAP AT ANY TIME.
 - 3. De-cock weapon if so equipped.
 - 4. Holster the weapon.
 - 5. Remove the magazine and top off the magazine with duty ammunition.
 - 6. Reinsert the magazine into the firearm. Making sure that the magazine is fully inserted.
 - C. Cleaning of weapons
 - 1. Make sure the weapon is safe and unloaded as described in section B-1 above.
 - 2. Clean weapon in the cleaning room.

3. Make sure your weapon is fully loaded before leaving the range.

D. Firing at the range.

- 1. Keep your finger <u>OUT</u> of the trigger guard until weapon is on target and you intend to fire.
 - 2. De-cock weapon (if so equipped) at the end of each firing exercise.
- 3. Unless instructed by a range officer or reloading of a weapon, *REHOLSTER* the weapon after each exercise.
- 4. Weapons are to remain holstered at all times unless firing or under instruction of a range officer.
 - 5. Experienced officers are expected to clear their own malfunctions.
- **HOWEVER**, if unsure. **KEEP** weapon pointed down range and ask for assistance from a range officer.
 - 6. NEVER go down range without permission or instruction of a range officer.
 - 7. ALWAYS wear Ear and Eye protection when on the range.
- 8. Horseplay, Joking, or Goofing around <u>WILL NOT BE TOLERATED</u> at the range.

IV. Firearms safety at home. (Child proofing)

- A. Keep weapons and ammunition separated and under lock and key.
 - 1. Locking weapons.
 - a. Revolvers
 - 1. Make sure the weapon is *UNLOADED*.
 - 2. Open cylinder place pad-lock or use handcuff around top strap.
 - 3. Use trigger lock or barrel lock. Weapon *UNLOADED*.
 - 4. Locking box. Keep key out of reach of children.
 - b. Semi-Auto Handguns.
 - 1. Make sure the weapon is UNLOADED.
 - 2. Use trigger lock or barrel lock.
 - 3. Bicycle type padlock through magazine well.
 - 4. Locking box. Keep key out of reach of children.
 - c. Long-guns:
 - 1. Best method is unloaded in a locked gun cabinet with action disassembled.
- B. Cleaning of weapons.

1. Clean weapons alone away from curious children.

V. Basic Safety,

- A. Treat <u>ALL</u> weapons as if they are loaded.
 - 1. NEVER take anyone's word for it.
 - a. Check then check again.
 - 2. <u>NEVER</u> point a weapon at anyone or anything you do not intend to shoot at.
- 3. <u>NEVER</u> engage in horseplay while in control of a weapon or while in an area where weapons are being used.
- 4. Keep weapons safely secured and separated from ammunition when not being used.

Page 9 of 2 POLICY

To provide for the safety of officers and other persons present on the Department's firing range specific rules and regulations have been established. All personnel shall adhere to the rules and regulations outlined in this order.

PROCEDURES

All persons present on the range shall adhere to general firearms and range safety rules at all times (Exhibit A) It is the responsibility of the designated range officer, and all officers present, to ensure these rules are adhered to while using the firing range.

A. Range rules.

- 1. A certified Firearms Instructor must be present when using the firing range,
- II. Only those Firearms Instructors, who have received training in the operation of the range equipment, and have been authorized by the Chief of Police, will be allowed to operate the Indoor Range.
- III. There will be no unauthorized shooting done in the Indoor Range by any officer.

 An authorized Firearms Instructor will supervise all Department firearms training.
- IV. Guests and non-sworn personal may not use the firing range or be in the live fire area unless given permission from the Chief of Police.
- V. The Firearms Instructor is in command of the range; officers shall adhere to all commands issued by the Firearms Instructor during range operations.
- VI. When using the range, all officers on the firing line must wear eye protection, hearing protection, and body armor.
- VII. Be alert for and adhere to the "Cease Fire" order. Anyone can call a "cease fire" if any unsafe condition develops or exists.
- VIII. All spent brass casings, used paper targets and other items used during the training, will be handled appropriately so that the range is left in clean condition after use.
 - IX. Only the ammunition approved by the Department, or issued by the Firearms Instructors, or designee, specifically for use in the facility may be fired in the range. Only approved weapons and ammunition will be used in the range.

- B. Use of range by Outside Agencies:
- I. Authorization for Outside Agencies and non-department personnel to use the range shall be made by the Chief of Police.
- II. Use of this range will be restricted to law enforcement agencies, and their personnel unless otherwise authorized by the Chief of Police.
- HI. Outside-agencies must-have a Firearms Instructor present when using the firing-range. All Firearms Instructors must be approved by the Mayfield Village Range Officer
- IV. Outside Agencies may not allow guest or any non-sworn personnel to use the firing range or be in the live fire area unless approved by the Chief of Police.
- V. Outside agencies utilizing the indoor range must supply their own ammunition.
- VI. Outside agencies must arrange training time through the Range Officer. Any unscheduled use of the range must be approved by the Range Officer or Chief of Police.

All provisions of this policy are subject to change to meet special conditions and circumstances as authorized by the Chief of Police.
