RESOLUTION NO. 2023-62 INTRODUCED BY: Mayor Bodnar

AN EMERGENCY RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR TO TRADE-IN SEVERAL WEAPONS IN THE POSSESSION OF THE POLICE DEPARTMENT TO ATWELL'S POLICE AND FIRE EQUIPMENT CO. FOR A CREDIT TOWARD THE PURCHASE OF NEW DUTY PISTOLS AND AUTHORIZING THE PURCHASE OF NEW DUTY PISTOLS FROM ATWELL'S POLICE AND FIRE EQUIPMENT CO. FOR A TOTAL COST OF \$2,023.00

WHEREAS, the Mayfield Village Chief of Police has recommended the purchase of 26 new duty pistols to replace the current Sig Sauer P320 .45 caliber pistols; and

WHEREAS, the current duty pistols were purchased in 2019 and are now not widely used by law enforcement, and are not compatible with optical sights; and

WHEREAS, therefore, the current Sig Sauer P320 .45 caliber duty pistols have been determined to be obsolete, unnecessary, and unfit for the Village Police Department's continued future use; and

WHEREAS, the Mayfield Village Police Chief reviewed three quotes for the purchase and trade-in of the duty pistols and recommends that Mayfield Village accept the quote from Atwell's Police and Fire Equipment Co.; and

WHEREAS, Atwell's Police and Fire Equipment Co. provided a quote in the amount of \$13,013.00 for 26 new Glock 9mm duty pistols, with a trade in credit for the 33 Sig Sauer P320 .45 caliber duty pistols in the amount of \$10,990.00, resulting in a total cost of \$2,023.00 for the purchase of the new duty pistols; and

WHEREAS, in accordance with Ohio Revised Code 721.15, Council deems it necessary and in the best interest of the health, safety and welfare of all Village residents to purchase 26 new Glock 9mm duty pistols and trade-in the current Sig Sauer P320 .45 caliber duty pistols to Atwell's Police and Fire Equipment Co.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF MAYFIELD VILLAGE, OHIO, THAT:

SECTION 1. The Council of Mayfield Village hereby finds and determines that the Police Department's 33 Sig Sauer P32 .45 caliber pistols are unfit for continued future use by the Village, approves the trade in of the 33 Sig Sauer P320 .45 caliber duty pistols for \$10,990.00 to Atwell's Police and Fire Equipment Co., and to have that amount credited toward the purchase of 26 new Glock 9mm duty pistols to Atwell's Police and Fire Equipment Co.

<u>SECTION 2</u>. Based upon Section 1 above, the Council of Mayfield Village does hereby authorize an expenditure in the amount of \$2,023.00 for the purchase of 26 new Glock 9mm duty pistols from Atwell's Police and Fire Equipment Co. for use by the Village's Police Department.

SECTION 3. The Council finds and determines that all formal actions of this Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal actions, took place in meetings open to the public, in compliance with all statutory requirements including requirements of Section 121.22 of the Ohio Revised Code.

<u>SECTION 4</u>. This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of health, safety and welfare of the residents of Mayfield Village, Ohio, for the reason that it provides equipment necessary to fulfill the obligations of the Police Department as set forth in the Mayfield Village Charter, Article V, Section 8 and Chapter 139 of the Codified Ordinances of the Village of Mayfield. It shall, therefore, take effect immediately upon the passage by the affirmative vote of not less than five (5) members elected to Council and approved by the Mayor or otherwise at the earliest time allowed by law.
