**AN EMERGENCY RESOLUTION  
AUTHORIZING A CONTRACT WITH AXON ENTERPRISE, INC.  
IN THE AMOUNT OF \$87,043.80 FOR BODY WORN CAMERAS  
FOR A FIVE-YEAR TERM**

WHEREAS, Mayfield Village previously entered into a 5-year contract with Axon Enterprise, Inc. for body worn cameras and associated equipment, services and features which expires in 2024; and

WHEREAS, Axon Enterprise, Inc. submitted a new quote in the amount of \$87,043.80 for body worn cameras and associated equipment, services and features for a new 5-year term starting in 2024; and

WHEREAS, the Mayfield Village Chief of Police reviewed the proposal; and

WHEREAS, the quote is at prices which are at or below the current prices for Axon body worn cameras and associated equipment, services and features as listed with the Ohio Department of Administrative Services at Public Contract MCSA0096; and

WHEREAS, Mayfield Village previously purchased dash cameras from Axon Enterprises which will be able to sync with the body cameras software allowing the Police Department to more efficiently receive, review and produce evidence; and

WHEREAS, based upon recommendation of the Mayfield Village Police Chief, it is in the best interest of the health, safety and welfare of all Village residents and inhabitants to enter into a new 5-year contract with Axon Enterprise, Inc. for 22 body worn cameras and associated equipment, services and features.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF MAYFIELD VILLAGE, OHIO, THAT:

SECTION 1. The Council of Mayfield Village does hereby authorize and direct the Mayor and President of Council to enter into a 5-year contract with Axon Enterprise, Inc., a copy of which is attached hereto and incorporated herein as **Exhibit "A"**, for 22 body worn cameras and associated equipment, services and features, at or below the current prices for Axon body worn cameras listed with the Ohio Department of Administrative Services at Public Contract MCSA0096, waiving competitive bidding, in a total amount not to exceed \$87,043.80, payable over 5 years, with the first payment due in January of 2024.

SECTION 2. The Council finds and determines that all formal actions of this Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal actions, took place in meetings open to the public, in compliance with all statutory requirements including requirements of Section 121.22 of the Ohio Revised Code.

SECTION 3. This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of health, safety and welfare of the residents of Mayfield Village, Ohio, for the reason that it provides for necessary services and equipment to ensure that the Village Police Department is properly supported. It shall, therefore, take effect immediately upon the passage by the affirmative vote of not less than five (5) members elected to Council and approved by the Mayor or otherwise at the earliest time allowed by law.
