Mayor Bodnar is easily reelected

Mayor Brenda Bodnar was the only Mayfield elected official to face opposition in the Nov. 7 election.

Bodnar outdistanced challenger Denise D. Calabrese by a count of 1,034 votes (75.4 percent) to 337, according to final, unofficial results from the Cuyahoga County Board of Elections.

Incumbent Village Councilwoman-at-Large Jennifer Jurcisek, Ward 1 Councilman Bill Marquardt and Ward 3 Councilman Dennis Murphy Jr. won without opposition.

Looking ahead to her third term, Bodnar said: "The next four years are going to have quite a few challenges for us. I think we'll be working hard on economic development.

"The goal is to create strategic opportunities for economic development. We want to collaborate with our existing businesses to help them grow and bring in new business to try and grow a little bit more diverse business base and increase jobs.

"We don't want to grow Mayfield Village; we want to do the old 'think big, stay small' thing. It's going to be imperative to budget wisely and spend cautiously."

"We do have promising economic development leads we're working on," she added. "Nothing we can talk about yet, but there are some interesting things out there that would help us grow our income tax base."

Mayfield's biggest taxpayer for many years has been Progressive Insurance. In July, Progressive announced that it would move employees from its Wilson Mills Road campus — Campus 1 at 6300 Wilson Mills Road — to a consolidated office at the company's North Commons Boulevard location.

When COVID-19 struck in 2020, Progressive allowed employees to work from home. While many companies have called employees back to offices, Progressive has had only up to 10 percent of its workforce back in its offices.

This has caused some uncertainty for Mayfield's finances. Asked about Progressive, Bodnar said: "Our income tax revenues from Progressive have remained steady, at a reduced level. We have planned for a permanent reduction in income tax revenues from Progressive."

"What we are waiting for now is the Ohio Supreme Court decision on whether we must issue income tax refunds for individuals who worked from home in 2020," she added.

"Our current reserves and tight fiscal management, combined with the high interest rate earnings environment we are currently experiencing, will help to sustain us operationally going forward.

"In the meantime, our focus has been on economic development,"

"We have limited real estate to work with, and are looking at ways she said. to grow and diversify our business base. This involves working with businesses to bring new uses to vacant properties, locating spaces for growth and providing performance-based incentives to bring new jobs and income taxes to the village."

Officers learned that the man had said in a post that he would, "make Columbine look like an Easter party."


Although the threat was not specific to any school, Mayfield schools were placed on a soft lockdown for the day.
