SUBJ: FLOCK Camera 5-year agreement.

Our Current FLOCK License Plate Reader (LPR) contract expires in June 2024. We currently pay \$2500 per year for each of our four LPR cameras. FLOCK recently announced in 2024 they are increasing the annual lease fee to \$3000 per camera. However, last week I was contacted by our FLOCK sales representative who offered a price lock at \$2500 per camera for the next five years on the condition we renew our contract before January 1st, 2024.

FLOCK cameras have been a useful asset to our Department, and I believe we should continue to use FLOCK cameras for the next five years.

RESOLUTION NO. 2023-72 INTRODUCED BY: Mayor Bodnar

AN EMERGENCY RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR AND PRESIDENT OF COUNCIL TO ENTER INTO A CONTRACT WITH FLOCK GROUP INC. FOR THE LEASE AND SERVICE OF AUTOMATIC LICENSE PLATE READERS IN THE AMOUNT OF \$50,000 FOR A FIVE-YEAR TERM

WHEREAS, based upon the recommendation of the Police Chief, it has been deemed in the best interest of the health, safety and welfare of all Village residents and inhabitants to install license plate readers in order to assist law enforcement efforts in the Village; and

WHEREAS, Flock Group, Inc. provides a software and hardware solution for automatic license plate detection through Flock's technology platform; and

WHEREAS, in or around June of 2022, the Mayfield Village Police Chief reviewed the proposal of Flock Group, Inc. and recommends that the Village enter into contract with Flock Group, Inc. for a two-year term in the amount of \$21,400.00 for the lease and service of automatic license plate readers; and

WHEREAS, at this time, due to the positive use of the license plate detection through Flock's technology platform in the Village, the Police Chief has reviewed a new proposal from the Flock Group, Inc. to extend the use of the technology for a term of five years at the current rate of \$10,000.00 per year, and recommends the same to Village Council for approval.

BE IT RESOLVED BY THE COUNCIL OF MAYFIELD VILLAGE, OHIO, THAT:

<u>SECTION 1</u>. The Council of Mayfield Village does hereby authorize and direct the Mayor and President of Council to enter into contract with Flock Group, Inc. for the lease and service of automatic license plate readers on the terms and in a form substantially similar to the Agreement attached hereto and incorporated herein as **Exhibit "A"**. The existing agreement is set to expire in June of 2024 and is hereby terminated, any early termination fee waived and this Agreement, effective December 31, 2023, shall be put in its place.

SECTION 2. Furthermore, the Council of Mayfield Village directs that the funds necessary under the contract with Flock Group, Inc. for the lease and service of automatic license plate readers be encumbered from the Capital Improvement Fund- Fund 410. The Capital Improvement Fund- Fund 410 was established by Ordinance No. 2022-12 to deposit revenue generated from the photo enforcement program implemented by Chapter 317 of the Village's Codified Ordinances to be used for law enforcement expenses that enhance response to traffic incidents and improve enforcement of traffic safety laws, as well as for other Village capital needs. Council finds that the lease and service of automatic license plate readers is in keeping with the purpose and intent of the Capital Improvement Fund- Fund 410 and thereby wishes to and

authorizes the Finance Director to use the Capital Improvement Fund- Fund 410 to pay for the costs and expenses under the contract with Flock Group, Inc.

SECTION 3. The Council finds and determines that all formal actions of this Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and that deliberations of this Council, and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including requirements of Section 121.22 of the Ohio Revised Code.

<u>SECTION 4</u>. This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of health, safety and welfare of the residents of Mayfield Village, Ohio, for the reason that it provides for necessary services and equipment to ensure that the Village Police Department is properly supported. It shall, therefore, take effect immediately upon the passage by the affirmative vote of not less than five (5) members elected to Council and approved by the Mayor or otherwise at the earliest time allowed by law.
