• Ordinance 2023-12 (Amended), entitled, "An ordinance amending certain Codified Ordinances relating to Certified Mail notification to also permit Express Mail and other forms of delivery with a signed receipt.") Introduced by Mayor Bodnar. (Administration) (First Reading – October 16, 2023) (Second Reading – November 20, 2023)

Council President Schutt asked, discussion?

Ms. Calta stated, I just wanted to mention that this is the legislation I made an amendment to. We are just going to keep it to the signed receipt, not the other language that says "or other form of delivery." Because the way the rules are, we will need to suspend the rules since this legislation is being amended after the second read. We have to go back and read it again and then just suspend the rules. Mary Beth, remind us.

Diane Calta has also requested an increase to the Law Director rates. I have a lot of materials to go through. I will be meeting with Diane and then bringing this to Council as quickly as I can.

There are no changes with regard to the Animal Warden.

Ron Wynne will be appointed as Finance Director until his successor is appointed in March of next year.

# 10) 2024 Yearly Assessment – Workers Compensation (\$104,823.00) (Finance Department)

Mr. Wynne stated this is our annual premium for our Workers Compensation insurance for next year. It is based upon 2023 wages. It is payable by the end of this year. By paying a lump sum, we will get a 2% discount.

#### 11) 2023 Year-End Transfers (Finance Department)

Mr. Wynne stated, I provided Council with a memo listing all of the transfers that need to be passed at Council.

### 12) MCIC Annual Meeting – Election of Officers (Finance Department)

Mr. Wynne stated, this is an annual meeting to elect the officers for next year. Council President Schutt asked, any questions or discussion?

There were none.

Council President Schutt stated, thank you, Mr. Wynne.

#### 13) Final Assessment Legislation – Sidewalk Project (Law Department)

Ms. Calta stated, everyone should have received a copy of this legislation attaching the list. Tom, is it final?

Mr. Cappello replied, I will check with Debbie. We went over it the last time.

Ms. Calta replied, I think we are down to a very small amount of residents. I would say it is probably a third of the original list, if not less than that. There was a combination of things. We had a fair amount of residents who paid. We had other residents that were able to address their issue.

Mr. Cappello stated, they hired someone to replace the blocks.

Ms. Calta replied, or to even them. Tom did a lot of work going out and talking to those residents to ensure those met the requirements. We have a very small list. I think there's \$3,000 being assessed in total. That was good news.

Council President Schutt asked, any questions or discussion?

There were none.

Council President Schutt stated, thank you, Ms. Calta.

### 14) NOPEC Legislation for Gas Opt-In (Law Department)

Ms. Calta stated, I think you all remember that we had someone from NOPEC here about a month or so ago to talk about their initiative. They made some recommendations, one of which was to pass legislation for the gas program that would create an opt-in. We have a program right now which is an opt-out program. Once they are out of the program, there is a delay in opting back

into the program so if we are able to pass this legislation, it would be a benefit for our community to those who want to opt back in. It will reduce that wait period. Instead of 30-60 days, it will be a lot less. We talked about this piece of legislation. The Mayor thought it would be of benefit to the residents. It will need to go through three readings and have a public hearing and then we will have our NOPEC representative back to speak about it as well.

Council President Schutt asked, any questions?

There were none.

Council President Schutt stated, thank you Ms. Calta.

### 15) Motorola Solutions Annual Service Agreement (\$39,604) (Police Department)

Chief Matias stated, this is our annual Service Agreement for the dispatch center. It's basically the warranty and service and maintenance agreement for all of the radios and equipment in the dispatch center. Years ago we had it where it was a five year contract. Now Motorola does a single year contract.

Council President Schutt asked, any discussion?

There was none.

Council President Schutt stated, thank you, Chief.

# 16) 2024 yearly contract with Ohio Geese Control (\$12,988.21) (Parks and Recreation)

Mr. McAvinew stated, thank you Council President. We enter into this contract every year to keep the geese off the field. They are defecating all over the field which has always been a problem. Ohio Geese Control handles keeping them off the field. It's a slight increase from last year in the amount of about \$500 a month.

Council President Schutt asked, any discussion?

There was none.

Council President Schutt stated, thank you, Mr. McAvinew.

17) Additional Expenditure for Equipment for new Police Motorcycle (original cost paid to Southeast Harley Davidson - \$9,973.39; additional expenditure to Southeast Harley Davidson - \$1,163.13) (Police Department)

Chief Matias stated, this is an additional piece of equipment. It's something for the exhaust system to allow the bike to run with more horsepower. It's something we wanted to add on. We were looking at doing the add on when we got the bike expecting we were going to get the bike next summer. We actually got something earlier than we expected. We are just adding this on.

Council President Schutt asked, any discussion?

There was none.

Council President Schutt stated, thank you, Chief.

### ANY OTHER MATTER BEFORE COUNCIL

Council President Schutt asked, are there any other matters to come before Council this evening?

Chief Carcioppolo stated, I just wanted to tell you all that we are scheduled to have our pick-up truck and SUV outfitted with lights and sirens over the next couple weeks. I am going to get the information to you about the vehicles which need to be declared surplus so we can sell them to *Govdeals.com*
