Department Head Reports:

Diane Wolgamuth (Administration) – Thank you, Council President. Reporting for Citizen's Advisory, the Committee is meeting on Monday, November 27th right after the holiday weekend. We will be meeting at the Bennett-VanCuren Historical House instead of in this building. On the agenda is an update from Joan Gottschling, President of the Historical Society. Also, Sam Clark-Cartwright, our new Senior Programming Coordinator is going to attend the meeting to give us an update on the changes she is making to our senior programming. That's all I have.

The P/Z vote on the conditional use permit will be held on December 4th. Because we are anticipating having a Special Meeting of Council that evening, approving P/Z's recommendation will be on the Special Meeting agenda as well. That's all I have.
