Ms. Calta replied, it may seem after the fact but the next step will be the Deed Restriction will get filed to limit it. But I could certainly have those conversations. We don't have an Appraiser picked out yet where we could have those conversations. I think the conversations from the beginning that started this whole process were that it was more situated for one dwelling unit, it made more sense for a couple of different reasons relating to where you could put the dwelling up there, etc., etc. That's how it started but I'll certainly ask those questions when we get to the appraisal. Just a couple of conversations I've had with Appraisers recently on other stuff, this is a vacant piece of property, it has so much acreage, there's so much that can be developed, it shouldn't change the price of it.

Dr. McGrath stated, I was not at the last meeting but I did go over the notes. From looking at that property, I would think it would be very challenging, it looks like there's only room for one driveway to get in there. To try and have two dwellings, you'd have to sell it to people that are willing to share the driveway. I think it would be difficult because the terrain is so dramatic. It would make an incredible home site for somebody whose willing to put an interesting home there, it would be amazing. But I'm not sure there's room for two without having to share a driveway.

Mr. Cappello stated, I believe originally it was one lot and they came in for a split, then they created both lots. It was one house I believe on the site and then there was a garage literally by the edge of the cliff.

Dr. McGrath said yes, I remember that, a classmate of my daughter lived there at the time.

Mr. Cappello said, I don't disagree, I think it's more conducive to combine them and make it one nice site.

Chairman Fikaris asked, any additional questions or comments?

There were none.

Chairman Fikaris stated, I would entertain a motion to approve a Lot Consolidation proposal as set forth.
