Comments From Council President Schutt

I just wanted to thank everybody for the event this past Saturday. The Trick or Treat Trail went off very well. It's the most kids I have ever seen attend this event. Thanks to the Parks and Recreation Department, the Fire Department in having their truck there, the Service Department as well and all of the volunteers. We would not have been able to hold this without all of the volunteers. Thank you for everyone who participated. I apologize if I left anyone out.

Just a reminder that our November Caucus meeting is on Monday, November 4th in Reserve Hall as the Board of Elections will be setting up in Civic Hall for voting on Tuesday, November 5th. So although we will be present on Monday, don't forget to vote on Tuesday the 5th. The Regular Meeting of Council is scheduled for Monday, November 18th back in this room.

New Patrol Officer Roscoe Lanier

Council President Schutt asked Roscoe to come up to the podium with his family members as well as whoever is going to pin you.

Chief Matias, before I administer Patrol Officer Roscoe Lanier's Oath of Office, do you have any comments?

Chief Matias stated, we are really excited to be adding Roscoe Lanier to part of our team. He was born in Appalachia, Alabama. The family moved up here when he was young. He is a graduate of Max Hayes High School. Roscoe spent three years on the Cleveland Police Department. For the past four years he has been serving out of the Cleveland Clinic Police Department. We gave our entrance examination several months ago and he scored number 1. He came in and gave a very impressive interview. With his interview and experience in law enforcement, we knew he was going to be a great addition to our team. So again, we are very excited to have him.

Council President Schutt stated, thank you, Chief. Council President Schutt administered the oath of office to Roscoe Lanier, Patrol Officer for Mayfield Village.

Council President Schutt stated, Congratulations.

• New Firefighter Niko Willrich

Council President Schutt stated, I will turn it over to Chief Carcioppolo for some comments.

Chief Carcioppolo stated, thank you, Council President. Tonight is a really joyful night. I just wanted to underscore that it's all possible because of the support of Mayfield Village Council. Niko, Jeremy and Brad all were initially interviewed after Council approved our modification to the wage ordinance for part-time employees. That brought them on over the last couple months through our interviewing and background process. They have been working with us part-time. That's a testament to your support of our department.

I want to thank everyone from Police and Fire for coming. As you can see, there's a huge turnout. I am proud of all of them. Both Police and Fire do an amazing job of their services. I wanted to also thank Administration, Mayor Bodnar because all of this is important. The swearing-in process is important.

To cover Niko real quick, a couple years ago, Gino DeLuca brings Niko to my office and says, hey, Niko's working with us. He's a good dude. He wants to talk about being a fireman. I talked to Niko and told him what he needs to do. Two years later, he's interviewing for part-time. He was on our full-time list. We moved him through that process. He's now our fullest full-time member. That's a testament to Gino's ability to find character because these jobs are hard as you have been all told. It's hard with shrinking interest in our field to find good employees and good staff that will stay. These three members we are swearing in tonight are good examples of what it takes to make it in our field. Without further ado, you can bring up your family and whoever you want pinning you.

Council President Schutt administered the oath of office to Niko Willrich as Firefighter for Mayfield Village, Ohio.

Council President Schutt stated, I will turn this over to Chief Carcioppolo for his comments.

Chief Carcioppolo stated, thank you. Brad and I met because he was a part of the grant that the State had for our health and wellness program. He was actually our personal trainer who came to the Fire station. He has a 4-year degree in exercise physiology and he worked over the Fire Department guys pretty good for a while. We got to know him. While he was doing that he was also going to school to become a firefighter/paramedic. He is done with his fire school and he is currently finishing his paramedic school right now. It was easy to interview and get to know if he was capable of fitting in with us well and that he is. So now he is one of our part-timers.

Jeremy came in from the outside. We didn't know him. He was Honorably Discharged from the Marine Corps. He has a lot of experience working in the hospital setting as a paramedic. He's fit in very nicely as well. We are happy to have both of them. Thank you for participating and coming to work with us.

Council President Schutt stated, thank you Chief.

Council President Schutt administered the oath of office to Part-Time Firefighter Brad Richmond and Part-Time Firefighter Jeremy Chepes.

He worked at Richmond Heights up until he came here. On periodic calls we would see each other. He filled in Assistant Chief Girbino's spot when he left and carried on the Fire Prevention Bureau which he left. Our Department misses him. We are picking up a lot of the work. Jeff has been doing a good job but Jeff will attest to the fact that it's a lot. In time, he will be at the same place as Mike was. When you are used to doing it, you can accomplish a lot more a lot quicker. We all miss him. We miss his knowledge, experience and skills and abilities, but we are happy to see him when we can. We are grateful for his proclamation and years of service.

WHEREAS, Assistant Chief Libens also served as a member of the Hillcrest Regional Fire Investigation Unit for 23 years; and

WHEREAS, Assistant Chief Libens retired from Mayfield Village on July 19, 2024; and

WHEREAS, during his tenure in Mayfield Village, Assistant Chief Libens used his years of experience, his education, and his example, to help guide all members of the Mayfield Village Fire Department to becoming dedicated public servants that will continue to serve Mayfield Village and surrounding communities; and

WHEREAS, Assistant Chief Libens has served the community of Mayfield Village with exceptional commitment and dedication and its residents and businesses have clearly benefitted from his knowledge and expertise.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF MAYFIELD VILLAGE, OHIO, THAT:

Assistant Fire Chief Michael Libens be and is hereby recognized for five years of dedicated and exceptional service to Mayfield Village and, as a token of appreciation, is awarded his Mayfield Village fire helmet. On behalf of residents, local businesses, department heads and staff, we congratulate him on his retirement and wish him many years of health and happiness with his children Riley and Mikaela, and wife Winnie.
