**AN EMERGENCY RESOLUTION
AUTHORIZING AN EXPENDITURE IN AN AMOUNT
NOT TO EXCEED \$13,323.00 TO LEWIS LANDSCAPING & NURSERY, INC.
FOR SOFTBALL FIELD ANNUAL MAINTENANCE**

WHEREAS, based upon the recommendation of the Mayfield Village Director of Parks and Recreation, it has been deemed in the best interest of the health, safety and welfare of all Village residents and inhabitants to provide annual preparations and maintenance to the softball fields; and

WHEREAS, the Mayfield Village Director of Parks and Recreation requested proposals from three companies for annual preparations and maintenance of the softball fields; and

WHEREAS, two of the three declined to quote the project for 2024; and

WHEREAS, Lewis Landscaping & Nursery, Inc. provided a proposal in the amount of \$13,323.00 for the annual maintenance and preparation of the softball fields; and

WHEREAS, the Mayfield Village Director of Parks and Recreation has reviewed the proposal of Lewis Landscaping & Nursery, Inc. and recommends that the Village accept it since the Village has successfully used Lewis Landscaping & Nursery, Inc. to perform this work in the past. The Director of Parks and Recreation recommends approval of an expenditure in an amount not to exceed \$13,323.00 to Lewis Landscaping & Nursery, Inc. for the annual maintenance and preparation of the softball fields.

BE IT RESOLVED BY THE COUNCIL OF MAYFIELD VILLAGE, OHIO, THAT:

SECTION 1. The Council of Mayfield Village does hereby accept the proposal and approves an expenditure not to exceed \$13,323.00 to Lewis Landscaping & Nursery, Inc. for the annual maintenance and preparation of the softball fields.

SECTION 2. The Council finds and determines that all formal actions of this Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and that deliberations of this Council, and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including requirements of Section 121.22 of the Ohio Revised Code.

SECTION 3. This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of health, safety and welfare of the residents of Mayfield Village, Ohio, for the reason that it provides for necessary services to ensure that the Village Parks and Recreation Department is properly supported, and work can timely begin. It shall, therefore, take effect immediately upon the passage by the affirmative vote of not less than five (5) members elected to Council and approved by the Mayor or otherwise at the earliest time allowed by law.

As per our conversation here is our quote for Early Season Infield Maintenance for the Red Field at Parkview Park for the 2024 Season.

Early Season Infield Maintenance

- Hand Cut all infield grass lines.
- All grass line would be laid out with string lines off foul lines.
- The infield Arc would be cut at a consistent distance off pitching rubber.
- Address any low area of heavy play.
- Add 2 tons of a State Certified Sand Clay Infield mix blended with a Diamond conditioner to alter any low spots on the infield.
- Heavy Drag and scarify all infield area to depth of 1 to 1 ¼ inches to work in larger particles of Diamond Conditioner.
- Laser Grade all existing materials.
- Add 3 tons Diamond Conditioner to the infield area.
- Top batter's box areas with Mound clay and light layer of Diamond Conditioner
- Add any needed Mound clay to Pitcher's mound.
- Drag all infield areas to finish grade.

The Total project cost of Red Field Early Season Infield Maintenance would be \$4383.00 plus any assessable sales tax. This pricing would include all labor equipment and materials needed to complete the project.

With provided project P.O. number, no deposit is required. Payment is due in full upon completion of project and receipt of invoice, 20 days from invoice date.
