**AN EMERGENCY RESOLUTION AUTHORIZING MAYFIELD VILLAGE  
TO PURCHASE A NEW POWER-PRO-2 COT FROM STRYKER SALES, LLC  
IN AN AMOUNT NOT TO EXCEED 34,535.82**

WHEREAS, based upon the recommendation of the Fire Chief, it has been deemed in the best interest of the health, safety and welfare of all Village residents and inhabitants to purchase a new power-pro2 cot and related equipment from Stryker Sales, LLC.

BE IT RESOLVED BY THE COUNCIL OF MAYFIELD VILLAGE, OHIO, THAT:

SECTION 1. The Council of Mayfield Village does hereby authorize the Mayor and President of Council to enter into a Sales Agreement with Stryker Sales, LLC for the purchase of a new power-pro2 cot and related equipment, a copy of which is attached hereto and incorporated herein as Exhibit "A".

SECTION 2. The Council finds and determines that all formal actions of this Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and that deliberations of this Council, and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including requirements of Section 121.22 of the Ohio Revised Code.

SECTION 3. This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of health, safety and welfare of the residents of Mayfield Village, Ohio, for the reason it provides for equipment necessary to ensure that the Village Fire Department is properly supported. It shall, therefore, take effect immediately upon the passage by the affirmative vote of not less than five (5) members elected to Council and approved by the Mayor or otherwise at the earliest time allowed by law.
