The Council of Mayfield Village met in Regular Session on Monday, March 18, 2024 in Mayfield Village Reserve Hall at the Mayfield Village Civic Center. Council President Schutt called the meeting to order at 7:00 p.m.

Comments From Mayor Bodnar

Thank you Council President. First, I would like to extend my sincere condolences to Tom Cappello on the loss of your father Nicola. I know having lost my father recently, it's a very tough time. You are in all of our prayers. If there's anything we can do, let us know.

Mr. Cappello stated, thank you.

Mayor Bodnar stated, all of the members of Council should have this at their seat tonight. We are sending out two letters to residents tomorrow going through the one sheet that provides basic information about the solar eclipse coming up on April 8th. It also gives some comments and tips on what people should do or not do during that time. The cover letter references the eclipse and talks about other things like ordinances that people should be aware of like the tree removal ordinance. It talks about the traffic signal, *Kindland* and some events we have coming up. Be sure to take a look at that in case residents ask you any questions.

Joan Gottschling

President – Mayfield Township Historical Society

I am here with Lorry Nadeau who is our Secretary and who won't come up here with me. We are here tonight to thank you for your generous donation you give us every year to help our Historical

Society. Without your generosity, it would be very hard for us to continue sometimes. We have six speakers during the year. We also maintain our Historic House and grounds and the gardens. We also provide for our 3rd grade tours. Last year after COVID, we had 365 students come through, all 4 Mayfield Elementary students there. It was great to have all 4 of them. Also, St. Francis came. They had not been here for two years. It was really nice to have them back. I appreciated it. The teachers did too. It was a nice break for them.

I wanted to read you a couple of the letters they wrote. The teachers asked them to write what they liked about the tour. We got pictures from them. This is from Penelope from St. Francis:

The log cabin had razors in the windows to keep the animals out. They wrote backwards for printing. Rich people used buttons to pay for stuff.

This is from Ella at Lander:

My favorite part was the school location. I liked seeing the rules from back then because it was really cool seeing the past and comparing it to the present. I also can't believe they whipped if the boys were mean to the girls. I also can't believe they had grades Kindergarten through 12th in one room. I have to say I had a great time at the Historical House. Thanks for spending your time with us. I also liked the log cabin. It was interesting to me because if you lived back then you probably would live in a log cabin and if you lived back then you wouldn't be alive today. If you were alive back then, you wouldn't have doors. Also bears can break into my house. If I lived back then, I might not have my family now. If I lived back then when it was snowing really hard, I would have to go to the bathroom and my restroom is in an outhouse or I would have to go to a pot inside the bedroom on the floor. If I lived back then I might have a different name. If I lived back then, I would not grow up the same way I do now.

From Center Elementary:

Dear Historical House:

Thank you for teaching us how life was long ago. I really enjoyed it. I learned a lot of things. First thing I learned was that a gun was used to contact my neighbors. My favorite thing was the school because the desks were all connected. You had to go outside if you had to go to the toilet.

I don't know why they liked that, but they liked that. We had quite a few enjoyable visits with the kids. It's one of our biggest highlights. We have 34 docents that we now trained to fill up the 91 timeslots we need for the 13 rooms over 7 different days, so it really takes a Village. We are hoping to open up during the summer weekends so we can get more people through the House. This year we will be purchasing a new riding mower, mulch for the garden and we will be fertilizing the grass. We are doing some maintenance to our basement. We also have to purchase supplies for our students to hand out to them. Some of the money coming in is from the quilt raffle sale tickets

and gift card raffle tickets. We really appreciate your continued support over the year and for everything you do for us. Thank you.

Diane Wolgamuth (Administration) – Thank you Council President. Reporting on Citizen's Advisory, the Committee met on February 26th and had a conversation about the *Kindland* initiative in Mayfield Village. We also had a presentation by representatives from the Community Partnership on Aging who talked about their volunteer program. This month we are scheduled for March 25th. We will have a follow-up discussion about *Kindland* and the ways we can reach our residents about how they can participate in the initiative. We are also going to do a website review. We are trying to get comments on our current website and how easy people think it is to navigate and any other comments or suggestions to improve it. That's all I have. Thank you.

Chief Matias (Police Department) - Thank you Council President. I just wanted to remind everyone that this Friday the Ohio School Safety Center is going to have their MILO virtual training at the Police station in our Range. It's not live fire. There is no live ammo used during the training. It's a lot of fun. I am inviting anyone from Council to come and participate in the training. It's from 1:00 p.m. to as late as 3:00 p.m. Let me know if you can make it. We will meet by the Police Station employee entrance at about 12:45pm (that is by the row of garage doors).

The other thing, just to give everyone a quick update on the theft of the vehicles from Deacon's. We were able to identify two of the suspects, one who has been arrested and charged, the other one will be soon. Both vehicles were recovered. There is still some other things going on with this, but I just wanted to give you an update. Our Detective Bureau is doing some great follow up. We are working with some other agencies to at least get this taken care of. That's all I have.

This effort was to try to procure any interest in part-time employment. Apparently all of our employees who are part-time are full-time elsewhere. That's mainly due to the fact that the credentials are kind of more professional. People don't really do it as much on the side. People who do it are full-time elsewhere and work part-time as a secondary means of income. But we will see if we can get some interest.

Mr. Meyers replied, thank you.

Chief Carcioppolo added, just to be clear, this is really not raising the rates. There's no tiers. We are just taking out the low end. Starting pay was \$15.00. You can go to McDonald's and made \$15.00 an hour.

I can give you an update at the next meeting as to where the State is and I can find out a little bit more about their timeline. I don't think they are ready to get their regulations in place in the next 30 days. It probably will be in the next couple of months.
