## AN EMERGENCY RESOLUTION AUTHORIZING MAYFIELD VILLAGE TO ACCEPT THE BID OF AND ENTER INTO A CONTRACT WITH C.A. AGRESTA CONSTRUCTION CO. IN THE AMOUNT OF \$637,014.00 FOR THE RIDGEBURY BLVD. IMPROVEMENT PROJECT

WHEREAS, based upon recommendation, it has been deemed in the best interest of the health, safety and welfare of all Village residents and inhabitants to repair a portion of Ridgebury Boulevard in Mayfield Village; and

WHEREAS, on December 19, 2022, Mayfield Village Mayor and President of Council entered into an Agreement with Cuyahoga County whereupon the County would contribute fifty percent (50%) of the actual cost of construction and construction engineering up to a maximum of \$247,500.00 (Resolution 2022-46); and

WHEREAS, the bids for the Ridgebury Blvd. Improvement Project were received, opened and tabulated as per published notice on May 10, 2024; and

WHEREAS, the bid of C.A. Agresta Construction Co. in the amount of \$637,014.00 was the lowest and best bid received; and

WHEREAS, the Village Engineer, who prepared the design and bid specifications for this project, has reviewed the bids and recommended that Council approve and accept the aforementioned bid for the Ridgebury Blvd. Improvement Project. A copy of his written recommendation and the bid tabulation is attached hereto and incorporated as Exhibit "A".

## BE IT RESOLVED BY THE COUNCIL OF MAYFIELD VILLAGE, OHIO, THAT:

- <u>SECTION 1</u>. The Council of Mayfield Village hereby accepts and approves the bid of C.A. Agresta Construction Co. in the amount of \$637,014.00.
- <u>SECTION 2</u>. The Council of Mayfield Village does hereby direct the Mayor and President of Council to enter into contract with C.A. Agresta Construction Co. in accordance with the specifications contained in the bid documents.
- SECTION 3. The Council finds and determines that all formal actions of this Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and

that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including requirements of Section 121.22 of the Ohio Revised Code.

SECTION 4. This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of health, safety and welfare of the residents of Mayfield Village, Ohio, for the reason that public bids must be awarded within 60 days and the Ridgebury Blvd. Improvement Project involves time sensitive construction. It shall, therefore, take effect immediately upon the passage by the affirmative vote of not less than five (5) members elected to Council and approved by the Mayor or otherwise at the earliest time allowed by law.
