### **Comments From Mayor Bodnar**

Thank you Council President. I have a couple of things to report on tonight. **OLD BUSINESS**

Introduced by Mayor Bodnar (Administration). (First Reading – June 16, 2025; Second Reading – August 4, 2025; Public Hearing August 18<sup>th</sup>) (Upon Third Reading and assuming passage and upon signature of the Mayor, this legislation will be submitted to the electors for a vote.)

Mrs. Juncisek, seconded by Mr. Arndt, made a motion to enact Ordinance 2025-07.

Council President Schutt asked, any discussion?

Ms. Calta stated, I was going to jump in on each of these and just give a brief summary. This one is addressing virtual meetings. You all remember during the pandemic the Governor of Ohio issued an emergency order that allowed municipalities to meet virtually during that pandemic. Once that order was lifted, we had no additional authority to do that. With the passage of this proposed amendment, we would be able to meet virtually. It would permit Council to hold virtual

meetings in limited circumstances and as directed by Village Council to adopt rules and regulations to address how those virtual meetings would be conducted to make sure that they are accessible to the public and there is public participation. It would be subject to Council's further adoption of a policy if the proposed amendment were to pass. The amendment is intended to insure the Village will be able to continue to conduct legislative business in the event of an emergency.

(First Reading – June 16, 2025; Second Reading – August 4, 2025; Public Hearing August 18<sup>th</sup>) (Upon Third Reading and assuming passage and upon signature of the Mayor, this legislation will be submitted to the electors for a vote.)

Mrs. Juncisek, seconded by Mr. Arndt, made a motion to enact Ordinance 2025-08.

Council President Schutt asked, Ms. Calta?

Ms. Calta stated, thank you. This is pretty much what it says. Article III, Section 12, we have a requirement that public notices currently are provided in a newspaper of general circulation. Sometimes I get the question, what is a newspaper of general circulation nowadays? That discussion was had to a large degree with the Charter Review Commission. The proposed amendment adds a notice requirement so in addition to still advertising in a newspaper of general circulation, notices will also be placed in the Village's preferred digital platforms. That would include things like the electronic sign at the Gazebo and on the Village's website which is where I think a lot of people go to to see what is going on with the Village.

Council President Schutt asked, discussion?

Mr. Gall stated, I have a question. Is it defined in the amendment what a digital platform is? I was assuming a digital platform was Facebook.

Ms. Calta replied, it could include that, yes.

Mr. Gall stated, but it doesn't describe what they are or what is recommended that they are going to be.

Ms. Calta replied, I can look at the language. We left it broad enough to mean electronic platforms. It could be Facebook if that is the medium where we are getting messages out. It could be the electronic sign. It definitely would be the website. If there's something else like Twitter or X or whatever we call that platform, it is meant to be broad enough.

Mr. Gall asked, but it is a platform we choose?

Ms. Calta replied, correct.

Mr. Gall stated, okay.

Ms. Calta stated, it could change over time.

Council President Schutt asked, any other discussions or questions?

- **Third Reading of Ordinance No. 2025-09**, entitled, "An Ordinance amending the Village Charter to clarify which Administrative positions are included in the classified service and unclassified service and subject to Civil Service." Introduced by Mayor Bodnar (Administration). (First Reading – June 16, 2025; Second Reading – August 4, 2025; Public Hearing August 18<sup>th</sup>) (Upon Third Reading and assuming passage and upon signature of the Mayor, this legislation will be submitted to the electors for a vote.)

Mrs. Jurcisek, seconded by Mr. Arndt, made a motion to enact Ordinance 2025-09.

Council President Schutt asked, Ms. Calta?

Ms. Calta stated, thank you. Article V, Section 6(B) sets forth the parameters for the Civil Service Commission to determine which employees of the Village will be in the classified service and that means they would be subject to civil service testing. Essentially you are competing for your jobs. That's what the civil service process is meant to create. This section identifies those within the classified service and those within the unclassified service. The proposed amendment updates the section. Part of it is largely a clarification. There's sort of a redundancy in there. A couple of

things are repeated. It's meant to clarify which administrative employees of the Village are in the classified and the unclassified. All department heads, excluding the Police Chief and Fire Chief and the Clerk of Council and all assistants and secretaries to department heads and elected officials are in the unclassified service. That means Police Chief and Fire Chief are in the classified service and pretty much everyone else I mentioned is unclassified. We are not changing the section. We are just clarifying it. We are not moving any positions in or out of the classified service. We are updating the language and making it clearer.

- **Third Reading of Ordinance No. 2025-10**, entitled, "An Ordinance amending the Village Charter to remove the ability of the Board of Zoning Appeals to grant use variances in non-residential districts." Introduced by Mayor Bodnar (Administration). (First Reading – June 16, 2025; Second Reading – August 4, 2025; Public Hearing August 18<sup>th</sup>) (Upon Third Reading and assuming passage and upon signature of the Mayor, this legislation will be submitted to the electors for a vote.)

Mrs. Jurgisek, seconded by Mr. Arndt, made a motion to enact Ordinance 2025-10.

Council President Schutt asked, Ms. Calta?

Ms. Calta stated, we have Article V, Section 12(A) and that is the section which deals with the powers and duties of the Board of Zoning Appeals. The Board of Zoning Appeals is granted authority over variances. In this instance, we are talking about use variances. Historically they have not been granted the authority over use variances. The difference between an area variance and a use variance is an area variance is someone comes in and they want to put a shed in their backyard and the setback line is 10 feet and they can't make it 10 feet, they only want to make it 8 feet, that's an area variance. A use variance has to do with the use of properties. In 2015, this section was amended to allow use variances in non-residential districts, so that meant in commercial areas. Essentially, it would create a use that is not expressly permitted to be in a commercial district. What we have found over the years is that it hasn't been a benefit to have this provision in the Village's Charter. It has caused some confusion. We really haven't found a need for it. There's been other efforts to create overlay districts to expand permitted uses, definitions, things like that that have been more beneficial to the commercial areas to keep the development in

those areas on the cutting edge of the uses that we are seeing for a commercial residence. If this were passed, it would remove the ability of the Board of Zoning Appeals to grant use variances. Back in 2015, the clause that was put in there will just pretty much be taken out if this proposed Charter amendment is passed. If there are any questions on this one, this one gets a little more detailed.

Ms. Calta replied, May 7, 1974. It became effective January 1, 1975. We have a lot of references in the Charter to January 1, 1975 as being the effective date. Also, that date is used for the staggering of terms for Boards and Commission members. There was a recommendation from the Charter Review Commission that it seemed kind of clunky to have the date in there and also reference it as the effective date. This is just a clean-up so that any references to that January 1, 1975 date will be changed to the effective date of this Charter.

Ms. Calta stated, for those of you that just were circulating petitions, this has to do with those petitions as well as other petitions. So initiative petitions, repealing ordinances, recall petitions. On your petition, there is a section that you have a petitioner’s committee. We don’t have to have that requirement in our Charter. We can take it out. We don’t have to form this committee. It is an added step that there’s been some confusion about because part of our Charter has in one section that you would normally look to for initiative petitions, it didn’t have this requirement in there but then the general provision that addressed all petitions required the petitioner’s committee. We had some confusion at some point with the Board of Elections where there was a review of just one section and the thought was that it wasn’t required but actually it is required. So to avoid that confusion the question came up, do we even need this requirement and what is the purpose of the requirement? The Charter Review Commission looked at it and said we don’t really need this. It’s in committees nominating candidates in the past. Also, this committee, if for some reason you are unable to fulfill your obligation on the ballot this committee that you appoint would choose your successor. The thought was instead of having your committee choose your successor if for some reason you can’t be on the ballot, that would be something that would then either be filled by Council or handled on the ballot. The recommendation was to remove this requirement. That’s what this section does.

Ms. Calta replied, I did. In speaking with the Fire Chief, we would like to have the opportunity to present to Council at Caucus a shorter version of the presentation that he gave to the Planning Commission. It's sort of facts and figures and data and some documents and graphs and things like that to support this ordinance as to why the recommendation is to prohibit any further assisted living, nursing homes or memory care facilities in the Village. With that, we would leave it on Second Read and then we would have a short presentation. The presentation to the Planning Commission probably lasted around an hour so we were thinking to shorten it up and give you a high level 15 minutes and then we can answer any questions that you might have. So if you could leave this on Second Read we could present at the Council Caucus on the 8<sup>th</sup> and then we would have it up for consideration for vote at the Regular Meeting on the 22<sup>nd</sup>.

Mr. Meyers asked, does a group home fall under this category?

Ms. Calta replied, it would not.

Mr. Meyers asked, why?

Ms. Calta replied, under State law, we can't prohibit group homes.

Mr. Meyers stated, but it's an assisted living. I'm just asking for clarification.

Ms. Calta stated, the definitions that we are looking at for this are not the same. We can talk about that at Caucus on how they are different.

Council President Schutt asked, any other discussion?

### **ANY OTHER MATTERS**

The cemetery is comprised of Mayfield Heights, Mayfield Village and Highland Heights. We couldn't get everyone on board to bite the bullet and refurb all of the monuments. We were talking about fundraisers but we did not have a 501(c)(3) so we really couldn't go down that road. Not to get too deep into the details but at a minimum we need to increase the amounts per municipality that we are contributing on a yearly basis which is barely covering the expenses let alone some of that money. We do have a nice fund where we could rehab some of the monuments. We are getting together soon. We are going to try to see if we can come to an agreement. I know Highland Heights has some things on their ballot that are keeping them behind. It's tough to get one municipality on board let alone when you can bring three in the room it's that much more difficult. There is good news. We just received word that we did get a \$2,500 grant from the State of Ohio for the restoration of the monuments. The ones in complete disrepair we can hopefully get started on depending on how much capacity the monument company has. We are working towards getting all of them restored eventually here. Any questions?
