AN EMERGENCY RESOLUTION AUTHORIZING MAYFIELD VILLAGE TO ENTER INTO A CONTRACT WITH TRUGREEN FOR LAWN CARE OF VILLAGE OWNED PROPERTIES IN AN AMOUNT OF \$17,858.44 PER YEAR FOR TWO YEARS

WHEREAS, based upon recommendation, it has been deemed in the best interest of the health, safety and welfare of all Village residents and inhabitants to engage a professional company to provide lawn care services for Village owned properties; and

WHEREAS, the Service Director solicited quotes for these lawn care services for Village properties; and

WHEREAS, the Service Director recommends that the Village Council enter into a contract with TruGreen for calendar years 2025 and 2026 in an amount not to exceed \$17,585.44 per year for lawn care services for Village owned properties.

BE IT RESOLVED BY THE COUNCIL OF MAYFIELD VILLAGE, OHIO, THAT:

- <u>SECTION 1</u>. The Council of Mayfield Village hereby accepts and approves the proposal of TruGreen for the provision of lawn care services for Village owned properties in the amount of \$17,858.44 per year for calendar years 2025 and 2026.
- <u>SECTION 2</u>. The Council of Mayfield Village does hereby direct the Mayor and President of Council to enter into a contract with TruGreen, a copy of which is attached hereto and incorporated herein as Exhibit "A."
- SECTION 3. The Council finds and determines that all formal actions of this Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including requirements of Section 121.22 of the Ohio Revised Code.
- <u>SECTION 4</u>. This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of health, safety and welfare of the residents of Mayfield Village, Ohio, for the reason that it provides for necessary lawn care services. It shall, therefore, take effect immediately upon the passage by the affirmative vote of not less than five
