AN EMERGENCY RESOLUTION AMENDING RESOLUTION 2024-50 TO AUTHORIZE AN ADDITIONAL EXPENDITURE IN THE AMOUNT OF \$1,310.00 FOR THE 2024-2025 VILLAGE SENIOR SNOW REMOVAL PROGRAM AND TO AUTHORIZE A PAYMENT IN TOTAL OF \$25,610.00 TO ARNOLD LANDSCAPE AND DESIGN, LLC FOR THESE SERVICES

WHEREAS, the Village's Senior Snow Removal Program is designed to provide snow removal services to assist seniors and adults with disabilities during the harsh winter months; and

WHEREAS, the Senior Snow Removal Program provides a vital service by ensuring that driveways are cleared of snow, allowing seniors to safely leave their homes for essential activities such as medical appointments, prescription pick-ups and accessing emergency services; and

WHEREAS, the Village's Recreation Department solicited bids from companies providing snow removal services; and

WHEREAS, Arnold Landscape and Design, LLC was one of the companies who submitted a bid to facilitate the 2024-2025 Senior Snow Removal Program; and

WHEREAS, the Mayfield Village Director of Parks and Recreation reviewed the proposal of Arnold Landscape Design, LLC and recommended that they be selected as one of the contractors for the 2024-2025 Village Senior Snow Removal Program; and

WHEREAS, on September 23, 2024, Mayfield Village Council passed Resolution 2024-50 authorizing and directing the Mayor and President of Council to enter into a contract with Arnold Landscape and Design, LLC for the 2024-2025 Village Senior Snow Removal Program in a total amount not to exceed \$24,300.00.

WHEREAS, during the season, it was necessary to add on more senior residents to Arnold Landscape Design, LLC's list of customers, thereby resulting in an increase due to the contractor in the amount of \$1,310.00; and

WHEREAS, the Director of Parks and Recreation recommends approval of this additional expenditure.

BE IT RESOLVED BY THE COUNCIL OF MAYFIELD VILLAGE, OHIO, THAT:

<u>SECTION 1</u>. The Council of Mayfield Village does hereby amend Resolution 2024-50 and authorizes an additional \$1,310.00 to be paid to Arnold Landscape and Design, LLC and in total approves a one-time expenditure of \$25,610.00 to Arnold Landscape and Design, LLC for the 2024-2025 Senior Snow Removal Program.

SECTION 2. The Council finds and determines that all formal actions of this Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and that deliberations of this Council, and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including requirements of Section 121.22 of the Ohio Revised Code.

SECTION 3. This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of health, safety and welfare of the residents of Mayfield Village, Ohio, for the reason that it will provide prompt payment for snow removal services previously rendered to program participants. It shall, therefore, take effect immediately upon the passage by the affirmative vote of not less than five (5) members elected to Council and approved by the Mayor or otherwise at the earliest time allowed by law.
