**AN EMERGENCY ORDINANCE
AMENDING EXHIBIT 1
TO MAYFIELD VILLAGE ORDINANCE 2026-03
TO ADJUST THE HIRING RANGE OF THE POSITION OF
“INFORMATION TECHNOLOGY (IT) MANAGER”
WITHIN THE ADMINISTRATION**

WHEREAS, Ordinance No. 2026-03 amended Chapter 153 of the Codified Ordinances of Mayfield Village and provides for current wages, benefits, and other terms and conditions of employment for employees of Mayfield Village, Ohio; and

WHEREAS, it has been deemed in the best interest of the health, safety and welfare of all Village residents to amend Exhibit 1 of Ordinance No. 2026-03 relative to the Hiring Range of the position of “Information Technology (IT) Manager.”

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF MAYFIELD VILLAGE, OHIO, THAT:

SECTION 1. Exhibit 1 of Ordinance No. 2026-03 be amended to adjust the Hiring Range of the position of “Information Technology (IT) Manager” from \$75,000 - \$90,000 to \$75,000 - \$100,000. The Hourly Hiring Range shall reflect a new hourly pay rate of \$33.65-\$48.07, as shown in Exhibit 1 attached hereto.

SECTION 2. All other provisions of the Village’s Codified Ordinances not inconsistent herewith shall remain in full force and effect.

SECTION 3. The Council finds and determines that all formal actions of this Council relating to the adoption of this Ordinance have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.

SECTION 4. This Ordinance is hereby declared to be an emergency measure immediately necessary for the health, safety and welfare of the residents of Mayfield Village, Ohio. It shall, therefore, take effect immediately upon the passage by the affirmative vote of not less than five

(5) members elected to Council and approval by the Mayor or otherwise at the earliest time allowed by law.
