**AN EMERGENCY RESOLUTION  
AUTHORIZING MAYFIELD VILLAGE  
TO ACCEPT THE PROPOSAL OF  
CLEAR GOLD AUDIO & LIGHTING LLC  
FOR SUMMER 2026 SOUND AND LIGHT PRODUCTION  
IN AN AMOUNT NOT TO EXCEED \$26,300.00**

WHEREAS, based upon recommendation, it has been deemed in the best interest of the health, safety and welfare of all Village residents and inhabitants to engage a professional company to provide special event sound production, including sound and light equipment rental and a sound technician for the 2026 summer season at The Grove, the gazebo, and for other special events as needed in Mayfield Village; and

WHEREAS, in 2023, quotes were sought and received, and Clear Gold Audio & Lighting submitted a proposal which included pricing for 2024, 2025 and 2026; and

WHEREAS, Clear Gold Audio & Lighting LLC provided production services to the Village for the 2024 and 2025 season; and

WHEREAS, the Mayfield Village Parks and Recreation Director recommends that the Village Council approve and accept the proposal for 2026 from Clear Gold Audio & Lighting LLC in an amount not to exceed \$26,300.00.

BE IT RESOLVED BY THE COUNCIL OF MAYFIELD VILLAGE, OHIO, THAT:

SECTION 1. The Council of Mayfield Village hereby accepts and approves the proposal of Clear Gold Audio & Lighting LLC in an amount not to exceed \$26,300.00.

SECTION 2. The Council finds and determines that all formal actions of this Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and that deliberations of this Council, and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including requirements of Section 121.22 of the Ohio Revised Code.

SECTION 3. This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of health, safety and welfare of the residents of Mayfield Village, Ohio, for the reason that it provides for necessary services to ensure that the Village events are

properly supported. It shall, therefore, take effect immediately upon the passage by the affirmative vote of not less than five (5) members elected to Council and approved by the Mayor or otherwise at the earliest time allowed by law.


