**AN EMERGENCY RESOLUTION
AUTHORIZING MAYFIELD VILLAGE,
TO ACCEPT THE PROPOSAL
OF MURPHY TRACTOR & EQUIPMENT CO., INC.
FOR THE PURCHASE OF A JOHN DEERE MINI EXCAVATOR
IN THE AMOUNT OF \$73,767.99**

WHEREAS, it has been deemed in the best interest of the health, safety and welfare of all Village residents and inhabitants to purchase a mini excavator for the Service Department to utilize for projects throughout the Village; and

WHEREAS, the proposal of Murphy Tractor & Equipment Co., Inc. for a John Deere mini excavator in the amount of Seventy-Three Thousand Seven Hundred Sixty-Seven and 99/100 dollars (\$73,767.99) was competitively bid through Sourcewell, a State of Ohio joint purchasing program of which Mayfield Village is a member (Resolution 2023-45); and

WHEREAS, the Service Director recommends that the John Deere mini excavator be purchased from Murphy Tractor & Equipment Co., Inc. for the proposed amount.

BE IT RESOLVED BY THE COUNCIL OF MAYFIELD VILLAGE, OHIO,
THAT:

SECTION 1. The Council of Mayfield Village hereby accepts and approves the proposal of Murphy Tractor & Equipment Co., Inc. in the amount of \$73,767.99 for the purchase of a John Deere mini excavator, which amount has been competitively bid and represents Sourcewell contract pricing.

SECTION 2. The Council finds and determines that all formal actions of this Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including requirements of Section 121.22 of the Ohio Revised Code.

SECTION 3: This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of health, safety and welfare of the residents of Mayfield Village, Ohio, for the reason that the mini excavator is a necessary piece of equipment needed to be placed in service as quickly as possible. It shall, therefore, take

effect immediately upon the passage by the affirmative vote of not less than five (5) members elected to Council and approval by the Mayor, or otherwise at the earliest time allowed by law.


