**AN EMERGENCY RESOLUTION  
AUTHORIZING AN AGREEMENT  
WITH DELTA DENTAL  
AS AND FOR AN EMPLOYEE DENTAL PROGRAM**

WHEREAS, the annual renewal evaluation of dental coverage with Delta Dental has been completed, and pricing for the upcoming policy year has been received, representing a 2.9% increase.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF MAYFIELD VILLAGE THAT:

SECTION 1. The Mayor and President of Council are hereby and herein authorized and directed to enter into an agreement for a period of one (1) year with Delta Dental effective April 1, 2026 through March 31, 2027, for an employee dental program as stipulated therein, at the rate of \$38.34 per month per employee for single coverage, \$77.59 per month for employee and spouse, \$91.05 per month for employee and children, and \$142.11 per month for employee, spouse and children. (Exhibit A).

SECTION 2. The Council finds and determines that all formal actions of the Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.


SECTION 3. This Resolution is hereby declared to be an emergency measure immediately necessary to maintain the employee dental program for the employees of Mayfield Village, Ohio which is due to expire on April 1, 2026. It shall, therefore, take effect immediately upon the passage by the affirmative vote of not less than five (5) members

elected to Council and approval by the Mayor or otherwise at the earliest time allowed by law.


