**AN EMERGENCY RESOLUTION
AUTHORIZING MAYFIELD VILLAGE
TO ACCEPT THE PROPOSAL OF AQUA POOLS, INC.
FOR REPAINTING PARKVIEW POOL IN THE AMOUNT OF
\$48,251.11 PLUS A 10% CONTINGENCY
FOR A TOTAL AMOUNT NOT TO EXCEED \$53,076.22**

WHEREAS, it has been deemed in the best interest of the health, safety and welfare of all Village residents and inhabitants to engage a professional company to prepare and repaint Parkview Pool; and

WHEREAS, quotes for pool repainting were requested and three quotes were received. Aqua Pools, Inc. submitted a proposal in the amount of \$48,251.11, which includes water blasting, acid wash and TSP neutralization prior to repainting with two coats of epoxy paint; and

WHEREAS, the Mayfield Village Parks and Recreation Director recommends that Village Council approve and accept the proposal of Aqua Pools, Inc. in the amount of \$48,251.11; and

WHEREAS, the Mayfield Village Parks and Recreation Director further recommends that a ten percent (10%) contingency, in the amount of \$4,825.11, be approved by Village Council for any unforeseen conditions, for a total expenditure not to exceed \$53,076.22.

BE IT RESOLVED BY THE COUNCIL OF MAYFIELD VILLAGE, OHIO, THAT:

SECTION 1. The Council of Mayfield Village hereby accepts and approves the proposal of Aqua Pools, Inc. to prepare and repaint Parkview Pool, plus a 10% contingency, in an amount not to exceed \$53,076.22.

SECTION 2. The Council finds and determines that all formal actions of this Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and that deliberations of this Council, and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including requirements of Section 121.22 of the Ohio Revised Code.

SECTION 3. This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of health, safety and welfare of the residents of Mayfield Village, Ohio, for the reason that Parkview Pool must be repainted in time for the 2026 summer season. It shall, therefore, take effect immediately upon the passage by the affirmative vote of not less than

five (5) members elected to Council and approved by the Mayor or otherwise at the earliest time allowed by law.
