**AN EMERGENCY RESOLUTION
AUTHORIZING AND DIRECTING THE MAYOR TO FILE
AN APPLICATION WITH CUYAHOGA COUNTY
FOR FINANCIAL ASSISTANCE THROUGH THE
SUPPLEMENTAL GRANT PROGRAM**

WHEREAS, Cuyahoga County, through its Department of Housing and Community Development, provides awards for community projects that help strengthen cities, encourage regional collaboration and improve the quality of life for County residents, through its Supplemental Grant Program; and

WHEREAS, Cuyahoga County awards grants to local communities for qualifying projects in amounts up to \$50,000; and

WHEREAS, the Village of Mayfield desires financial assistance to assist with the installation of a replacement pedestrian bridge in the Wetlands Park, located at 425 North Commons Blvd., near The Grove Amphitheatre and Parkview Pool, the cost of which is estimated at approximately \$100,000; and

WHEREAS, Council deems it necessary and in the best interest to the health, safety and welfare of all Mayfield Village residents to submit an application to Cuyahoga County under the Supplemental Grant Program.


NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Mayfield, County of Cuyahoga and State of Ohio, that:

SECTION 1. Mayfield Village Council approves the filing of an application for financial assistance for installation of a pedestrian bridge in the Wetlands Park.

SECTION 2. The Mayor, and/or her authorized representative, is hereby authorized and directed to execute and file an application with Cuyahoga County, provide all information and documentation required, and take any other actions necessary to become eligible for possible funding assistance through the Supplemental Grant Program, including providing proof of commitment of additional funding to complete the bridge project.

SECTION 3. The Council finds and determines that all formal actions of this Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and that deliberations of this Council, and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including requirements of Section 121.22 of the Ohio Revised Code.

SECTION 4. This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of health, safety and welfare of the residents of Mayfield Village, Ohio, for the reason that timely submittal for funding is required to participate in the Cuyahoga County Supplemental Grant Program no later than July 13, 2026. It shall, therefore, take effect immediately upon the passage by the affirmative vote of not less than five (5) members elected to Council and approved by the Mayor or otherwise at the earliest time allowed by law.
