**OPEN PORTION**

Chairman DiFranco stated, we have one case to consider today, consideration of Case #2026-01, the applicant is CBIZ, PPN #831-13-013 Beta Investment Partners, 6685 Beta Dr, Glavin Industries. The abutting property owners on Beta Dr and SOM Ctr have been notified.

**OATH**

Chairman DiFranco stated, because we are a Quasi-Judicial Body, anyone wishing to speak must be sworn in. Chairman DiFranco administered the Oath to Dan Glavin, President Glavin Industries.

Chairman DiFranco invited Mr. Glavin to proceed with his presentation.

### **Presentation *by* Dan Glavin, Glavin Industries**

Dan Glavin said, thank you. As many of you probably know over the years this business has changed hands a couple of times. Skoda Minotti changed to Marcum a couple of years ago and then recently has been acquired by CBIZ. My company did the Marcum change over when we put up the new letters for Marcum, 36" custom ordered, like the new letters will be 36". Obviously that makes the logo a little bit bigger, the icon they call it. Their request was to try and get the same letter height. It's actually not entirely different total square footage. At this size, it's a couple square feet more because of the way the icon goes up and below the letter. But, this is what they're requesting.

It'll be the same construction on materials. The sign we make in the same process, install it the same way. The only difference is that they're moving it on the building a little bit. You can see on the right hand side of this photo here, they had it on this little shorter building before, a little bit farther down the street. But now this is their main entrance.

Chairman DiFranco stated, just to be clear, on the first variance, we don't have an allowance for a wall sign?

Mr. Russell replied, we don't have anything in our code identifying a wall sign. So it's an automatic variance for that, just to have a wall sign.

Chairman DiFranco asked, and Marcum had theirs on the other side?

Mr. Russell replied, I looked through the files, I didn't see anything if a variance was ever granted for that or a permit. So I'm not sure when that happened, that was prior to me.

Chairman DiFranco stated, and the second variance is a request for an 18" height variance to allow for a 46" tall logo with letters of 36" in height. The code allows a maximum height of 18".

Mr. Russell replied, for the letter size. We don't have anything for logos. The letter size themselves, 18" is the maximum height.

Chairman DiFranco asked, is that 36" with logo?

Dan Glavin replied, yes. The Marcum letters were 36" as well (holding up a sample letter).

Ms. Jeanblanc stated, we've had this with other buildings on Beta. It's the distance to the building, it's very difficult for people to find the business.

Chairman DiFranco asked Diane, do you have any concerns?

Ms. Calta replied, I talked with Ms. Weber before the meeting tonight and neither one of us had any concerns. Just out of curiosity, what is that logo?

Dan Galvin replied, I have no clue. In this day and age, people like to do these kinds of things. I'm not exactly sure what it means.

Ms. Calta said, no concerns from legal.

Mr. Michalko asked, is there any electricity for lighting on it?

Dan Glavin replied, no. It's non-illuminated.

Mr. Andrzejczyk asked, it's going to be blue & green?

Dan Glavin replied, yes.

Chairman DiFranco asked Dan, any concerns?

Mr. Russell replied, no concerns.

Chairman DiFranco stated, this is unique I think on Beta in that it's further back from the road than most of the other buildings on Beta. Does that sound accurate?

Mr. Russell replied, it's pretty far back, yes.

Mr. Michalko said, the only two that I know that are farther back is Canon and MARS.

Chairman DiFranco asked, any other concerns from Board Members?

There was none.

Chairman DiFranco stated, I'd like to read the criteria in granting a variance;

In granting an Area Variance, the Board shall determine that one or both of the following factors are met by the request:

- a. The conditions upon which an application for a Variance is based are particular to the subject property with respect to the physical size, shape or other characteristics of the premises or adjoining premises, differentiating it from other premises in the same district: or
- b. The Variance would result in an improvement of the property that is more appropriate and more beneficial to the community than would be the case without granting of the Variance.

Chairman DiFranco entertained a motion for approval.

**DECISION**

Ms. Jeanblanc, seconded by Mr. Michalko made a motion to approve the variances as requested;

1. A request for a variance from Section 1185.11(a) to allow for construction of a Wall Sign.
2. A request for an 18" height variance from Section 1185.11 (b) to allow for a 46 inch tall logo with letters of 36" in height. The code allows a maximum height of 18" for sign letters.
