The Council of Mayfield Village met in Special Session on Monday, May 4, 2026 in Mayfield Village Reserve Hall at the Mayfield Village Civic Center. Council President Schutt called the meeting to order at 7:12 p.m.

- **First Reading of Ordinance No. 2026-08**, entitled, "An Emergency Ordinance authorizing and directing the Mayor and President of Council to enter into a purchase and sale agreement, setting forth the terms and conditions of the sale of certain vacant real property owned by Mayfield Village, Ohio, located at 691 SOM Center Road, known as Permanent Parcel Number 831-22-032, no longer needed for any municipal purpose, and to only be used for the construction of one new single family residential home." Introduced by Mayor Bodnar. (Administration) (Requires suspension of the rules tonight and upon passage this legislation will take effect immediately upon signature of the Mayor.)
